Unfortunately, at the moment I am unable to put my hands on the source of that statement. While I believe it came from "*Upon the Shoulders of Giants*", Vol. I or II (or its Errata) by the Zeitlers, et al, I don't have hard copies of either and can't find my copy of the excerpted pages from it. You probably will not readily appreciate that I was in the midst of reorganizing my genealogical files when we abruptly agreed to have our old home placed on the Spring 2015 Virginia Garden Club Tour; consequently all my haphazardly-organized files were immediately piled into boxes and shoved under the bed for sorting out later. "*Later*" hasn't arrived yet. ② At any rate, I will go on a hunt for it and will let you know if and when it shows up.

My recollection of the essence of the matter is that James Henry was asked to make a statement having to do with the settlement of his siblings' shares in the family estate, at least one of whom, John, was deceased, having been killed in the War of 1812. In making his statement, he enumerated all the off-spring of his parents, both living and deceased, and

included a David, hence my interest in the matter. But, having no immediate interest in the others, I did not list them in my paper on my GGG GF David.

In the meantime, Allison, you might try for a copy of the two books, and their errata, on an Inter-Library loan to see if the discussion on his deposition can be found. I will, as promised, try to find my copy of the excerpt. Sorry I can't do better at the moment.


