The only other way to obtain copies is for you or someone on your behalf to come into our research room to view the record. We are currently offering limited appointments as we are in the office about 2 days per week. When in house, you can view it at no cost, and can take pictures with a camera or phone (no flash) for free. Any digital or print copies would be \$1.00 per page in house (it is the higher fee as this record is bound and will need to have staff assistance to utilize our book scanner). This particular record is 416 pages.
